- Email address

THEME PAPER:

It need to be emailed to cwfsis2020@nuals.ac.in . The file name of the paper should start with your name.

- The Full paper should not exceed 4000 words (exclusive of footnotes).
- Co-authorship is permitted with a maximum of two authors only.
- In case of co-authorship at least one author must attend the seminar to present the paper.
- The main text should be in Times New Roman with font size 12 and spacing of 1.5.
- The footnotes should be in Times New Roman, font size 10 with single spacing.
- One inch margins on all sides should be maintained and citation should be blue book style.
- All submissions must be the author's original and unpublished work. Plagiarized submissions will be disqualified.
- Selected works will be considered for publication in the Journal of Centre for Women and Family Studies (CWFS),
 NUALS. For that an undertaking is sought from the authors, stating that it is not published or given for publication.
