



THE SIXTH EDITION

Format of the Competition

Despite these unprecedented times, we at NLIU strive to make the competition bigger and better. The competition shall be organized **virtually** through video conferencing. The details of the platform will be made available in due course. The format of the competition shall consist of four rounds of pleadings. First, preliminary rounds will be held where each team shall submit arguments from both the sides, i.e. claimant(s) and respondent(s). The top 8 teams shall subsequently advance through the knockout stage-the quarterfinals followed by the semi-finals. The last two surviving teams will compete for the winner's trophy in the grand finale. The teams shall argue sides allotted to them as per the rules of the competition.

Registration

The registration fee for the competition is

- **INR 3000 for Indian teams,**
- **USD 100 for International teams.**

The institutions can register themselves provisionally through their designated Moot Court Association for the Competition by sending an email of such registration to tankhamoot@nliu.ac.in.


