Eligibility criteria & Composition

- This competition is open for all the law students from Different recognized Universities/Colleges/Institutions across the country. Multiple teams are allowed from University/College/Institute.

<u>Rules</u>

- The dress code must be business formals.
- The competition shall be conducted in two rounds.
- Both rounds will be conducted on same day.
- In Round I, an objective type test shall be conducted for all the teams which shall consist of 20 MCQs (based on correct spelling, meaning, application, relevance of legal maxims). Maximum time allowed shall be 20 minutes. Each correct response shall be awarded with +1 mark and each incorrect response shall be awarded with -0.25 marks. No response shall be awarded with 0 marks.
- The top 16 individuals from Round 1 securing relatively higher marks shall be carried forward to Round II. Round II shall be an oral round in which each team shall be asked a total of 10 questions turn by turn. The questions shall be based on correct spelling, meaning, application, relevance of legal maxims. Each correct response carries 10 marks. There shall be no negative marking for incorrect response. Each team shall be allowed only 30 seconds to answer a question. The team scoring the maximum marks shall be declared the winner. The team scoring second highest marks shall be declared the Runner up.

- The word limit for the articles must not be less than 1500 words (exclusive of footnotes).
- The file name of the submission must be as follows:
- In case of Single Author ' 'e.g. Author's name.docx
- In case of Co-authors '&' e.g. Author's&Co-author.docx
- The last page of the submission must include the following information:
 Name of the Author(s), and the Name of the Institution.
- The content should be the original work of the writer and should not have been given to any other competition or for any publication. Plagiarized content shall not be entertained.
- Judgment shall be based on points given on the criteria of content, language & uniqueness.
- · The decision of the judges shall be final and binding.
- All rights arising from the submissions made by the participants are automatically vested in Editor, LawInternships (The Online Law School).
- Non-compliance with either of the guidelines mentioned above will result in an automatic rejection of the submission.

- 7. Advocates appearing on the behalf of the Parties (only if mentioned in the proposition.)
- 8. Team Code
- 9. Other relevant details

Submission Format

- The language of the submission should necessarily restricted to English.
- Word limit: 1500-2500 (including footnotes)
- Format: The submissions should be made in MS Word/.doc/.docx and PDF format. Both formats must be attached. The submissions must be in Times New Roman, Size 12 with 1.5 Line Spacing.
- Page Number: Bottom right
- Team Code should be necessarily mentioned in every page.
- · Citation methodology to be followed in Bluebook 19th or 20th Edition.

Penalties

- Notwithstanding, any other rule, following are the penalties which shall be levied on participants on grounds of proven misconduct in any manner, whatsoever:
- Disqualification on grounds of:
- Non-Submission of Judgment
- Upon disclosure of the identity of the participant (name and college name) in the submission.
- Deduction of the marks on grounds of:
- Submission of Judgment not complying with the above-mentioned rules shall attract a penalty of two marks.
- Submission of Judgment (Soft Copy) after the date of submission shall attract the penalty of ten marks per day.
- Participants must be very careful about their contents. We will entertain original works only. Maximum limit to which plagiarism would be entertained is 10% (excluding citations), if the same is found beyond this limit it would attract negative marking.

National Memorial Drafting Competition, 2021
