The Cell organises intra-college competitions; conducts various workshops and lectures; holds webinars for students wishing to pursue their career in this field; and hosts its flagship event: the ADR Weekend. The Cell aims to instil a perspective, attitude and aptitude for resolving disputes among the students.

ABOUT THE COMPETITION



The **AZB-GLC National ADR Triathlon** is a distinctive ADR competition conducted by the Cell. With immense research and deliberation, the unique format of the “ADR Triathlon” was conceptualised.

Each team of 3 participating members represents only one party throughout the three rounds of the competition. The same problem progresses throughout the Competition, giving participants a slice of reality where developments progressively complicate a dispute.

- The first round shall be a Client Counselling Round, where a pair of counsels from each team will attempt to advise an in-house client.
- The second round shall be a Negotiation session.
- The third and last round shall consist of Mediation.
- All three rounds shall be cumulatively scored.

It comes close to the actual process of Dispute Resolution in the Status Quo, more so than any existing competition.

Students get an opportunity to dig deep into the problem, beginning from counselling the client, to negotiating the dispute with the other party across the table, and finally attempting to settle the dispute with the help of a mediator present to facilitate the process.

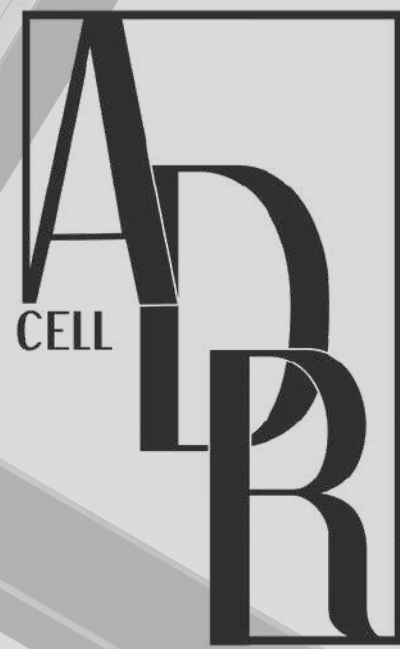
