- Co-authorship is allowed to a maximum of two persons.
- The format specified below has to be strictly adhered to.
  - File type – All files submitted should be either in .doc or .docx with file name as Participant's Name-STAPADR.
  - Body – Times New Roman, size 12, line spacing 1.5, justified.
  - Footnotes – ILI Rules of Footnoting, Times New Roman, size 10, line spacing 1, left aligned
  - End notes are not to be used.
- Word Limit of essay (inclusive of footnotes) is a minimum of 3000 words and maximum of 4000 words.
- The body of the manuscript should not contain any personal details of the author, so as to enable anonymous screening.
- The work submitted should be original and unpublished and must not be under simultaneous consideration for publication elsewhere.
- Plagiarised entries shall be rejected. The Faculties in charge reserve the right to use any plagiarism checker to vet the submissions.
- The entries should be sent through this submission form only. The entries would be assessed on the basis of the following parameters: originality, relevance to the topic, coherence and content
