## ABOUT CHRIST (DEEMED TO BE UNIVERSITY)

CHRIST (Deemed to be University) was born out of the educational vision of St. Kuriakose Elias Chavara, an educationist and social reformer of the nineteenth century in South India. He founded the first Catholic indigenous congregation, Carmelites of Mary Immaculate (CMI), in 1831 which administers CHRIST (Deemed to be University).

CHRIST (Deemed to be University) was established as 'Christ College' in 1969. # INSTRUCTIONS AND PROCEDURE FOR REGISTRATION

## Eligibility

The Competition is open for all students who are pursuing a three-year or five-year Law Degree Course in Universities/Colleges/Law Departments in India, as recognized by the Bar Council of India. The Participants should send a picture of their University ID Card for verification.

## Venue

The 9th National Trial Advocacy and Judgment Writing Competition 2023-23 shall be held, from 15th to 17th February 2024. It will be held offline.

## Procedure for Registration

Participation in the 9th SLCU National Trial Advocacy and Judgment Writing Competition is restricted to 30 teams only. Institutions/Teams interested in participating in the Competition will have to provisionally register by sending an email to [criminallaw.committee@law.christuniversity.in](mailto:criminallaw.committee@law.christuniversity.in) and only after confirmation of a provisional slot by the Organizers, should they complete the formalities of the final registration. The slots shall be reserved based on a 'first come' basis for the first 30 teams.

The teams should register through their respective Official College Email ID or any other recognized student association Email ID. Once the teams have provisionally registered, then the teams will be sent a confirmation mail providing them with the link for the Final Registration.

Only the teams who have received confirmation of provisional registration after receiving an email from the Committee must submit the registration form. Kindly note that only one team per College/Institution/University shall be permitted to take part in the Competition. The last date for provisional registration is 15th January 2024, and the last date for final registration shall be 31st January 2023. The main invite shall be made available only to those teams that preregister with the organizing committee.

### Registration Fees

The registration fees are as follows:

Without Accommodation: INR 2,500 + GST

With Accommodation: INR 2,500 + INR 6,750 (INR 750 per head per night) + GST = INR 9,250

The payment procedure shall be emailed to the teams once they provisionally register for the Competition.

## DIRECTIONS TO REACH THE CAMPUS

CHRIST (Deemed to be University) is easily accessible from all parts of Bangalore City. Here are some driving directions and bus route numbers to help you get here.

### From Central (Majestic) Railway Station and Kempegowda Bus stand:

Drive towards Corporation (Hudson) Circle

Drive through Devanga Hostel road to reach Mission road

Take a right turn under the flyover to join K H road (double road) and drive straight until you reach Lalbagh Main Gate.

Take a left and drive straight ... you will cross Wilson garden, NIMHANS Hospital and then take the Dairy Circle Fly Over. In the process you will find CHRIST (Deemed to be University) on the right side.

The distance is approximately 10 kms.

### Bus Routes from Kempegowda Bus Stand (Majestic):

Ask for CHRIST (Deemed to be University)/ Devasthanana /Dairy Circle Bus Stop  
365, 353, 168 D, 170,171A, 171B, 171C, 171 D, 165 340,342 356,360B etc

Landmark: Dairy Fly-Over.

### Bus Routes from Shivaji Nagar Bus Stand:

Ask for CHRIST (Deemed to be University)/ Devasthanana/Dairy Circle Bus Stop.

166 (Direct), 348 D, 368 Landmark: Dairy Fly-Over.

### From the new Bengaluru International Airport:

The distance is approximately 42 kms.

You may take BIAS-7 of Vayu Vajra Volvo Bus Service from the Airport to Koramangala and get down at CHRIST (Deemed to be University).

The travel time will be 1.30 Hrs approximately.

You may also take BIAS-5 of Vayu Vajra Volvo Bus Service from the Airport to get down at Shanti Nagar Bus Station.

You may then take a taxi/autorickshaw/bus to reach CHRIST (Deemed to be University) which is 3 kms away.

A/C Shuttle Services from Airport will depart every 30 minutes.
