

RULES AND REGULATIONS

GENERAL RULES FOR ALL:

Each team will be assigned a team code after registration, which will be communicated by 15th September 2025.

• DRESS CODE:

Participants are required to adhere to the following dress code while present in any Court Room during the Competition.

- Ladies: White Salwar and Kurta or White Shirt and Black Pant/ Black Skirt, Black Coat and Black Shoes.
- Gentlemen: White Shirt, Black Trousers, Black Tie, Black Coat and Black Shoes.

THEME

The moot proposition for the ALC International Moot Court Competition 2025 is based on International Law.

LANGUAGE

The official language for the Competition shall be English only.

• ELIGIBILITY

The Competition is open to 'bona fide' students currently enrolled in a 5-year Integrated Law Programme or a 3-year LL.B. Programme at universities and institutions recognized by the Bar Council of India. International participants must also be 'bona fide' law students enrolled at universities or institutes recognized by the competent authority or affiliating body in their respective countries.

TEAM COMPOSITION

- 1. Each team shall consist of three members. No observer/additional member can be part of a team in any capacity. There shall be two speakers and one researcher in the team.
- 2. The teams shall identify such speakers and researcher during registration.
- 3. Formal registration of the teams shall be done on 27th September 2025 at the Venue at 9AM.
- 4. Any change in the team composition shall be intimated to the Organizers before the formal registration on the venue.
- 5. The organizing committee has the exclusive right to decide in case of any dispute related to the registration. The decision of the organizing committee in such a case shall be final.
- 6. Each team shall be assigned a code upon registration.
- 7. There shall be 2 Preliminary Rounds followed by a Quarter Final, Semi Final and Final Round.

GENERAL INSTRUCTIONS FOR ORAL PLEADINGS

- **1.** Each Preliminary and Quarter Final Round of the Competition shall consist of 40 minutes of Oral Pleadings. Both the sides shall be allotted 20 minutes each.
- **2.** Semi Final and Final round shall consist of 60 Minutes of oral pleadings. Both the sides shall be allotted 30 minutes each.
- **3.** Prior to the beginning of the Preliminary and Quarter Final Round, each Team shall indicate to the Court Master how it wishes to allocate its 20 minutes among:
- (a) its first Speaker,
- (b) its second Speaker, and
- (c) rebuttal (by Petitioner/ Appellant) or Surrebuttal (by Respondent).

No single Speaker shall plead for more than fifteen (15) minutes, including rebuttal or surrebuttal. Similarly, the teams shall indicate their allocation of 30 minutes before the beginning of the Semi-final and Final round. No speaker shall plead for more than 20 minutes during Semi-Final and Final Round including Rebuttal or Surrebuttal.

- **4.** The extension of time is at judges' discretion. The judges may at their discretion, extend the total time for the team for oral arguments beyond 20 minutes or 30 minutes' allocation, as the case may be, up to an additional 05 minutes per Team. Speakers asked to further expand upon arguments may, in this instance, appear for more than the 25 minutes or 35 minutes' individual limit, as the case may be.
- **5.** Order of Submission- The order of the oral submissions in each Round at all levels of the Competition shall be:
- Petitioner/Appellant 1
- Petitioner/Appellant 2
- Respondent 1
- Respondent 2
- Rebuttal (Petitioner/Appellant 1 or 2)
- Surrebuttal (Respondent 1 or 2)
- **6.** Each Team may reserve up to 5 minutes for Rebuttal or Surrebuttal. Ex Parte Procedure- In extreme circumstances, such as when a Team fails to appear for a scheduled Oral Round, the Court Clerk, after waiting for 15 minutes, may allow the Oral Round to proceed ex parte.
- **7.** In an ex parte proceeding, the attending Team presents its oral pleadings, which is scored by the judges to the extent possible as if the absent Team had been present and arguing. In such a case, the Team that fails to appear for the scheduled Round forfeits all the points of the Oral Round and gets disqualified from the competition.

- **8.** Oral Communication during the Oral Rounds shall be strictly limited to:
- Oral Courtroom Communication between Counsel and Judges.
- Oral Courtroom Communication and Activity at Counsel Table.
- Every courtesy shall be given to Speakers during Oral Argument.
- Communication at the counsel table shall be in writing to prevent disruption, and Teams shall avoid all unnecessary noise, outbursts, or other inappropriate behavior.
- Any Penalties imposed under this Rule shall be deducted from the Oral Scores of both Speakers
 of the offending Team.
- **9.** Written communication among team members seated at the counsel table shall be facilitated through the court master. A written note may be passed to assist the speaker in answering issues raised by the judges.
- **10.** Communication among the speaker and team members seated at the counsel table is permissible through written notes, ensuring they comply with procedural decorum.
- **11.** Communication with spectators or team members not present at the counsel table is strictly prohibited during proceedings.
- **12.** Teams are permitted to hand over supporting documentation to the judges; however, this must be done exclusively through the court clerk. The teams should not engage in any form of unethical, unprofessional, or wrongful conduct during the entire period of the Competition. Teams should not attempt to influence Judges / Organizers in any manner.

General Rules for Online Rounds (International Teams):

- a) The Oral Rounds for the competition will take place virtually via Zoom platform. The Zoom link will be shared with the international participants one day prior to the competition, i.e., on Friday, 26th September 2025.
- b) It shall be the responsibility of every team to ensure a stable internet connection. The audio and video of every participant shall be clear with a proper background.
- c) All participants should mandatorily join with their laptops or desktops and in no circumstance join with any other device, such as mobile phones.
- d) Any further instruction related to the online rounds will be notified by the organizing committee.

GUIDELINES FOR MEMORIAL SUBMISSION

MEMORIAL FORMAT

- 1. The memorial shall not exceed 40 pages, including the cover page.
- 2. The cover page must be Blue for the Petitioner/Appellant and Red for the Respondent.
- The memorial must be typed on A4-sized paper.
- 4. Each page must be printed on one side only.
- 5. The memorial must be spiral-bound

FORMATTING REQUIREMENTS

FOR MAIN TEXT

Font Type: Times New Roman

Font Size: 12 Line Spacing: 1.5

Margins: 1 inch on all sides

FOR FOOTNOTES:

Font Type: Times New Roman

Font Size: 10 Line Spacing: 1

Teams shall cite authorities in the memorial with footnotes following a uniform system of citation (Bluebook 20th Edition). Pages should be numbered at the bottom and spaced in the middle of each page of the memorial.

• MEMORIAL CONTENT:

- The cover page of the memorial should contain the following details:
- Team Code in the upper right-hand corner.
- Name and place of the forum.
- Name of the parties and their status.
- "Memorial Filed on Behalf of Applicant/Prosecutor" (Blue cover).
- "Counsel Appearing on Behalf of Respondent/Defendant" (Red cover).

The memorial should contain the following heads:

- i. Table of Contents
- ii. List of Abbreviations
- iii. Index of Authorities/List of References
- iv. Statement of Jurisdiction
- v. Statement of Facts (not exceeding 2 pages)
- vi. Statement of Issues
- vii. Summary of Arguments (not exceeding 2 pages)
- viii. Arguments Advanced
- ix. Prayer (not exceeding 1 page)

ADDITIONAL GUIDELINES

- a. Teams are strictly prohibited from mentioning their personal details anywhere in the memorial.
- b. After submission of memorials, no revision, supplements, or additions shall be allowed.
- c. Teams must strictly adhere to the mentioned structural format.
- d. The soft copies of the Memorial from each side shall reach the Organizers at Asian Law College via mail on **mcc@alc.edu.in** in pdf. format as per the deadline.
- e. Attachments shall be titled as
 - [TEAM CODE] [P/A] for Petitioner/Appellant side and
 - [TEAM CODE] [R] for Respondent side. e.g. 007 P/A and 007 R.
- f. 5 hard copies of the Memorials from each side i.e. 10 copies in total must reach the Organizers by the deadline on the following address: Asian Law College Plot A2, Block C, Sector 125 Noida, UP, 201303.

- 1. The Researcher's Test will take place on Saturday, 27th September at 10 AM in Asian Law College, Noida Campus.
- 2. The Researcher's Test for International (online) Participants shall be done via online mode in Zoom. Further details will be shared post registration.
