
About us



GENERAL INFORMATION

ELIGIBILTY

- 1.The competition is open to every student pursuing a five-year or three-year course in law from any recognized Schools/Colleges/Universities.*
- 2.For eligibility, it is hereby clarified that all the participants in one team shall belong to one institution only.
- 3.No cross-institutional composition of teams is allowed.
- 4. The provisional registration is to be done by the respective institutions officially.
- 5.Each institution can reserve a **maximum** of **three slots** in the provisional registration.

TEAM COMPOSITION

- 1.Each team shall comprise 3 participants- one mediator, one client, and one counsel.
- 2. The roles of the participants must remain the same throughout the rounds.

FORMAT

- 1.The 3rd Samanvay International Mediation Competition, 2025, will be held in a hybrid mode, that is, partly online, and partly in the campus of Himachal Pradesh National Law University, Shimla, surrounded by the serene Himalayas.
- 2.There will be a total of 6 rounds 2 Preliminary Rounds, one Octa-Final, one Quarter-Finals, one Semi-Finals, and the Final Round.
- 3.The allocation of the slot is contingent on the availability of the total number of slots available with the Cell.
- 4.Post Preliminary rounds, ballots will be scored for each team, and the top 16 Negotiating pairs and Mediators will qualify for the Octa-Finals.
- 5.Post Octas, ballots will be scored for each team, and the top 8 Negotiating pairs and Mediators will qualify for the Quarter-Finals.
- 6.The Teams that qualify for the Quarter Final rounds shall be invited to the HPNLU, Shimla Campus for competing in the Advanced Rounds.

^{*}Participation of teams from foreign universities is subject to political clearance given by the Ministry of External Affairs, Government of India.

7.Post Quarters, the top 4 Negotiating pairs and Mediators shall qualify for the Semi-final Rounds on a knockout basis.

8.Post the Semi-Finals, the top two performers from each category of roles, i.e., Negotiating pair and Mediator, played by the participants, will qualify for the Final round, on a knockout basis.

MODE

- 1.The Competition shall be held in Hybrid mode, whereby the Training, Workshop, Inaugural Ceremony, Preliminary Rounds and Octa Final Round shall be conducted virtually via Google Meet, while the Quarter Finals, Semi Final and Final rounds of the competition shall take place physically at the university campus.
- 2.Kindly note that the Offline conduction of the advanced rounds shall be contingent on the weather conditions of Himachal Pradesh and may be shifted to the Online mode in case the same is not favorable.

REGISTRATION

- 1.Provisional registration shall be opened for all eligible institutes from which thirty two (32) teams will be selected for the competition.
- 2.Institutes interested in sending across a team must fill the following <u>Provisional</u> <u>Registration form</u> latest by 8th August 2025.
- 3.Upon selection by the Organizing Committee, an email confirming the slot of the institute along with the final registration form and payment link will be sent on the concerned email ID (either of the registered ADR Cell or of the point of contact).
- 4.The Registration fee for the competition is INR 15,000/- per team (for Indian teams only), and USD 200 (for international teams only), which is inclusive of the cost of food, accommodation, registration and other logistical charges. However, the fee does not include Transportation costs.
- 5. Please note that this fee is non-refundable.
- 6.Final Registration of the team is subject to the successful payment of the registration fee within the stipulated time.
- 7.The Final Registration shall be completed only when the participants pay the registration fees, which shall be done on or before **20th August, 2025**.
