## **FORMATTING & CITATION**

Manuscripts should be in Times New Roman, size 12, 1.5 spacing, justified text. Citations should be through in-text hyperlinks for online sources, and OSCOLA (4th Edition) endnotes for offline sources.

## **SUBMISSION PROCEDURE:**

We invite students, academicians, legal practitioners, and HR professionals to contribute their original, unpublished writings to our weekly newsletter Shram.
