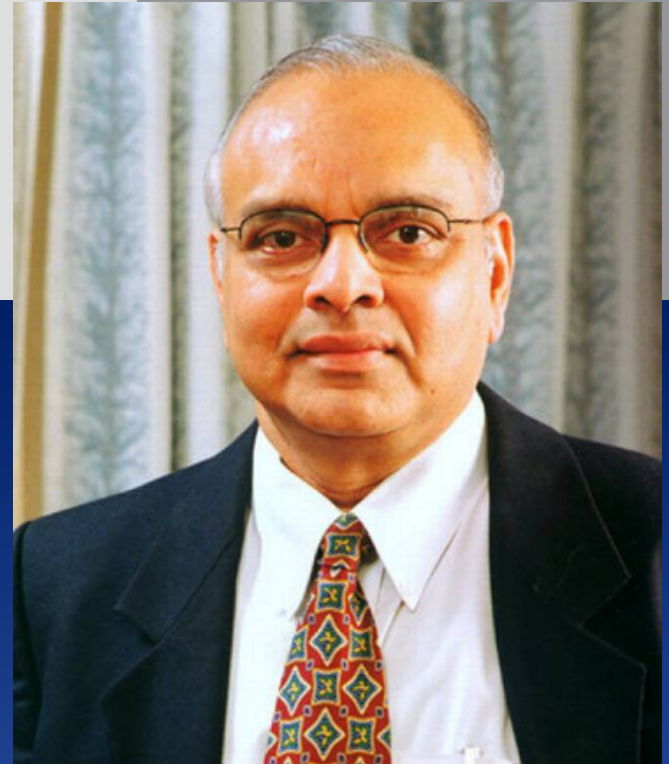

Rules & Regulations

→ General Rule:

- Participating Team" means the team which has registered itself for the Competition as per the Rules given below.
- All the Rules are only inclusive and not exhaustive for the competition.
- Rules should be strictly adhered. Any deviation there from would attract disqualification or other penalties mentioned subsequently.
- All decisions by the Organizers are in case of any disputes/doubts etc. will be final. The Organizers may make such rules and procedures at any point of time, as they deem fit. Imposition of penalties including disqualification rests solely with the Organizers in case of failure to comply with the rules and deadlines.

→ Eligibility:

- All students who are pursuing an Integrated 5-year LL.B. or 3-year LL.B. program from recognized Law Schools, Universities, and Institutions in India and law programmes outside India shall be eligible to participate.
- Each institution can be represented by maximum three teams.

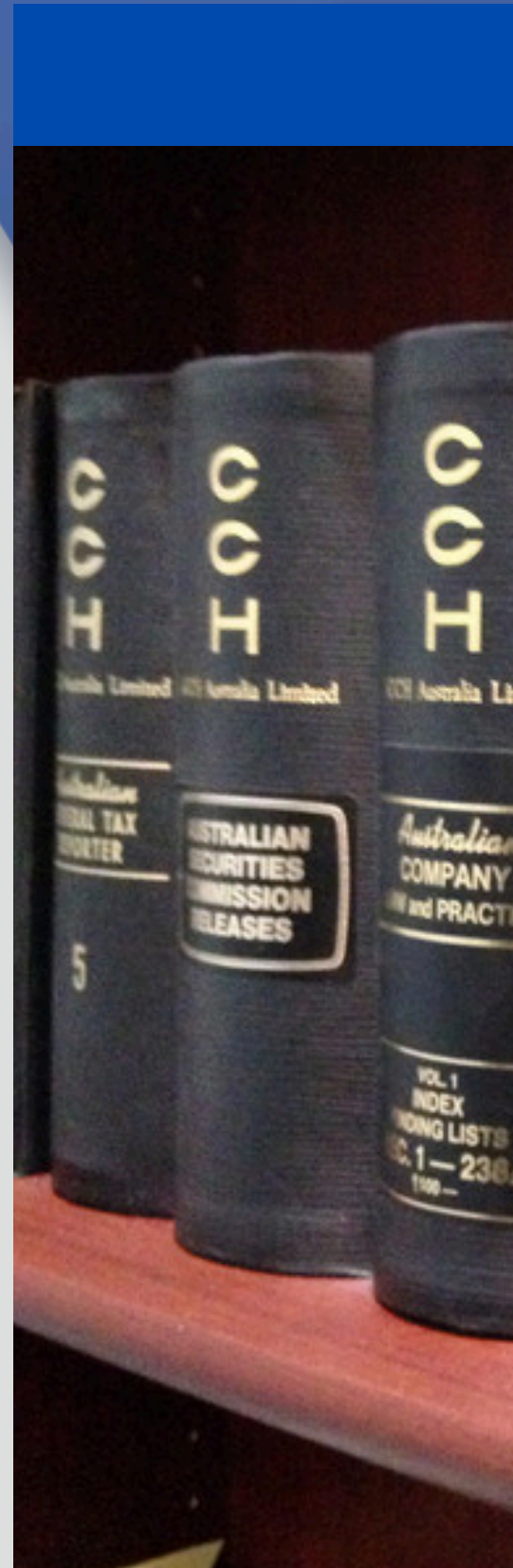
→ Language:

- The official working language of the Moot Court Competition shall be English.

→ Dress Code:

During all the Days of the competition the participants shall be in Formal wear only.

- Male participants are required to wear a Full Formal Suit i.e., Black Trousers, White Shirt, Black Tie, Black Coat and Black Formal Shoes.
- Female participants are required to wear a Full Formal Suit i.e., Black Trousers, White Shirt, Black Coat and Black Formal Shoes or Indian Formal Dress i.e., White Salwar Suit / Saree Along with Black Coat & Black Bellies.

→ Team Composition

- Each participating team may consist of either two (2) or three (3) members.
- A team of two members shall include one as speaker, and another member as both speaker and researcher.
- A team of three members shall include two speakers and one researcher.
- All members of a team should belong to the same institution/department.
- Any team, intending to change the team composition of the team shall intimate the OC by sending an e-mail at MOOTCOURT@iudehradun.edu.in

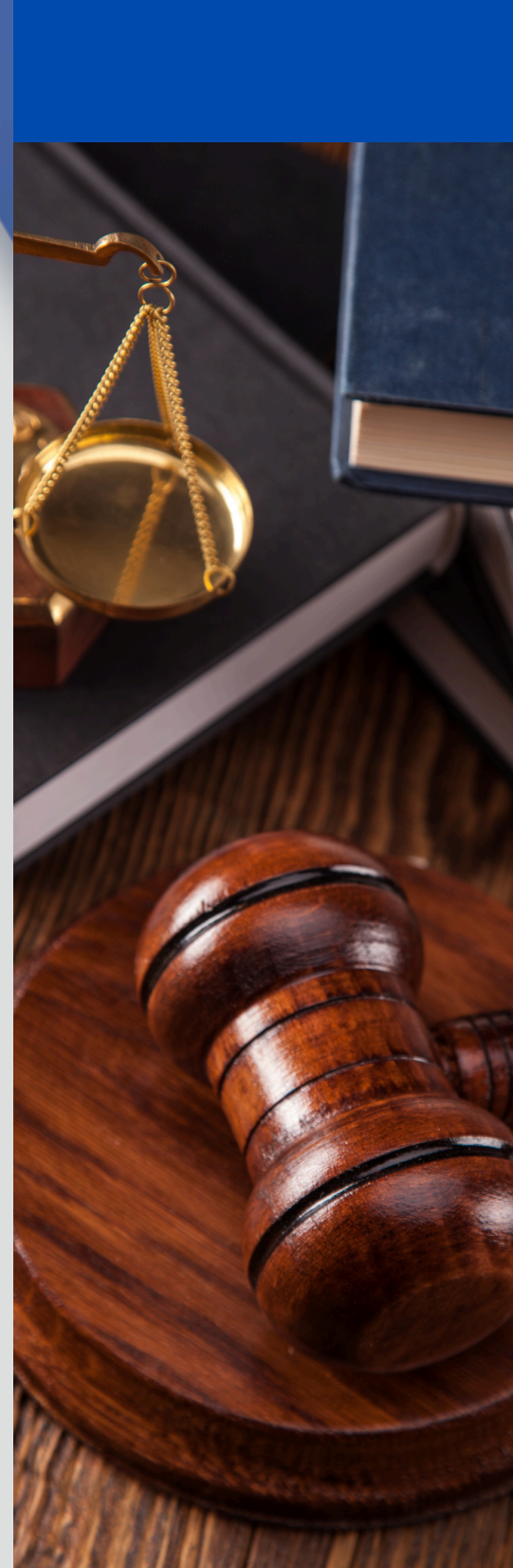
→ Identification of Teams:

- Each team shall be identified only by the unique team code allotted to them after the completion of the registration process.
- No team shall indulge in any activity which shall disclose their identity or the identity of their institution in any manner. Such disclosure shall invite penalties including disqualification. The final decision shall be as per the discretion of the organizer.
- Teams shall use only their Team Code for identification purposes. Names of participants or their colleges should not appear on or within the written submissions. Signature pages are prohibited.

→ Scouting:

Scouting shall be deemed to have happened if the speakers, researcher or any other person affiliated with a team is found:

- Witnessing, hearing, observing, etc. the oral submissions in a Round, except where the Round is one in which the team to which he/she is affiliated is participating in;
- Reading a Memorial of a team except where: it is of the team to which he/she is affiliated; or the Memorials have been obtained on account of an exchange of Memorials prior to a Round of the team to which he/she is affiliated.

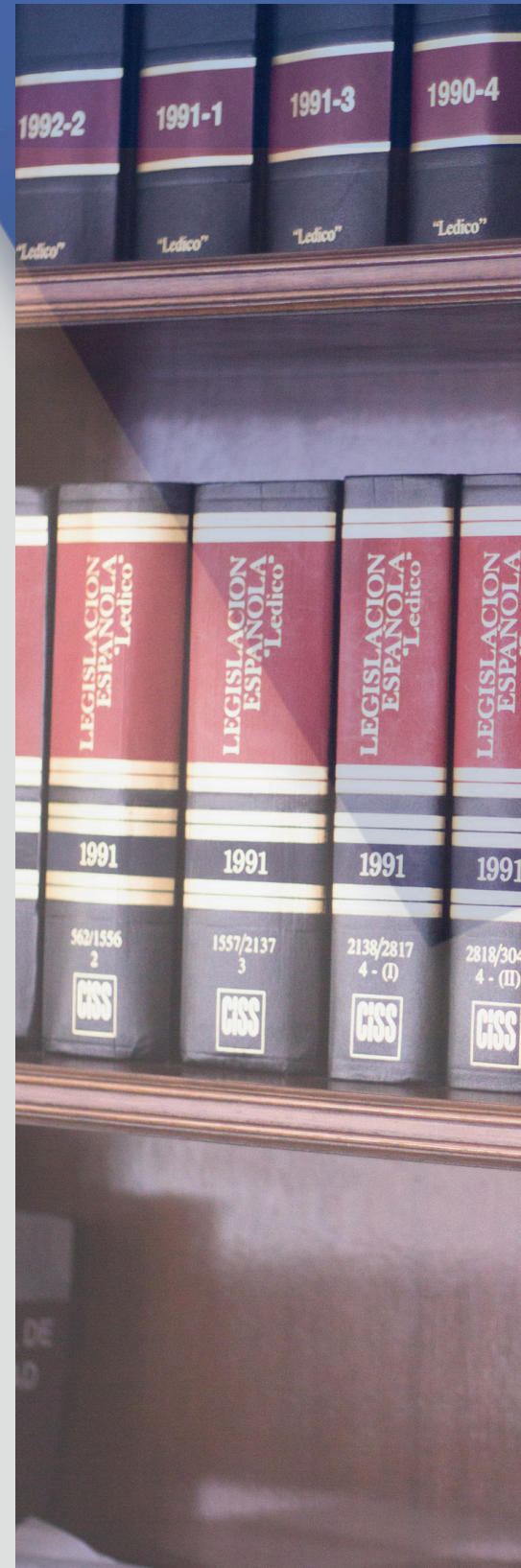

→ Registration:

- Each participating team shall fill out the registration form by 31st January, 2026; 23:59 IST for registering in the competition.
- Upon successful completion and submission of the registration form, each team will receive a confirmation e-mail from the OC
- The registration fees for National Teams is INR 3000/- (without accommodation). Accommodation assistance will be provided. There is no registration fees for International Teams.
- Incomplete registration form will not be accepted.
- The team shall nominate one member of the team as a primary contact person, who shall communicate all information concerning the competition. It shall be the responsibility of the person nominated to convey all such information to the other member(s) of the team.

→ Payment:

- National teams shall be required to make a payment of INR 3000/- (without accommodation) as the fee for registration to participate in the Competition. The OC will provide Accommodation Assistance, if required.
- All the payments shall be made on account details that will be provided after the registration on the email id.
- The Organizing Committee will confirm the registration only after receiving the payment and duly filled registration form within the respective time limit.
- No refund shall be given under any circumstance in case of withdrawal.



Memorial Formatting Guidelines

General Text Formatting:

- Font Type: Times New Roman
- Font Size: 12 pts
- Line Spacing: 1.5 line spacing
- Alignment: Justified
- Page Margins: 1 inch on all sides
- Paper Size: A4

Footnotes Formatting:

- Font Type: Times New Roman
- Font Size: 10 pts
- Line Spacing: Single spacing
- Alignment: Justified

Page Numbering:

- Pages up to the Summary of Arguments must use small Roman numerals (i, ii, iii, etc.).
- Pages from Written Arguments onward must use Hindu-Arabic numerals (1, 2, 3, etc.), starting from 1.
- Page numbers must be placed at the bottom right corner of each page.

Page Limitations:

- The Memorial, including the cover page, must not exceed 30 pages.

Cover Page Guidelines

Color Scheme:

- Requesting Party Memorial Cover Page: **Blue**
- Requested Party Memorial Cover Page: **Red**

Contents of the Cover Page:

- Team Code (top right corner)
- Name of the Court
- Case Title
- Year of the Competition
- Side Represented (Petitioner or Respondent)

Mandatory Sections in the Memorial

Each Memorial must include the following sections in order:

- Cover Page
- Table of Contents
- List of Abbreviations
- Index of Authorities
- Statement of Jurisdiction
- Statement of Facts (non-argumentative)
- Issues Raised
- Summary of Arguments
- Arguments/Pleadings Advanced
- Prayer for Relief



Submission Guidelines

Memorial Preparation Requirements:

- Each team must prepare Memorials/Written Submissions for both parties to the dispute (Requesting and Requested Party).

Soft Copy Submission:

- One soft copy of the Memorial for each side must be submitted on the e-mail id- MOOTCOURT@iudehradun.edu.in .
- The file name must be the allocated team code followed by the the party represented:
- Team Code Example :
- For the Requesting Party: TC-01[Requesting]
- For the Requested Party: TC-01[Requested]

Hard Copy Submission:

- Each team must submit three hard copies of the Memorials for both sides.
- The hard copies must be identical to the soft copies submitted.

Submission Deadlines:

- Soft Copy Submission Deadline: 2 February,2026.
- Hard Copy Submission Deadline: 7 February, 2026.

Penalties for Late Submission:

- A delay in submission will attract a penalty of 1 point per day per side.

Confidentiality and Anonymity:

- Memorials must not contain any information identifying the institution or participants.
- Team codes, assigned by the Organizing Committee, must be used for identification.

No Revision Policy:

Once submitted, no revisions, supplements, or additions to the Memorials are allowed.
